

Monmouthshire Building Society

Insurance Prize Draw– Terms & Conditions

- 1) You will be included in the prize draw if you complete a quotation with Monmouthshire Building Society for home insurance. Alternatively, you may also be entered into the prize draw if you complete a quotation for insurance through Monmouthshire Insurance Services (MIS).
- 2) To enter the prize draw, you must have a home and/or personal possessions to insure through Monmouthshire Building Society; or an appropriate business, property, home and/or possessions, or personal circumstances that require insurance through Monmouthshire Insurance Services.
- 3) All quotations must be obtained between 9.00am on Monday 1st November 2010 and 5.00pm on Friday 21st January 2011. If we are unable to provide you with a quote, you will not be entered into the prize draw.
- 4) For home insurance quotations, you can obtain a quotation by telephoning 01633 844 390 during normal office hours. Quotations are also available from our branches or from our website at www.monbs.com using our online quotation system.
- 5) For insurance quotations through MIS, you can obtain a quotation by telephoning 01633 844 450 during normal office hours. Quotations can also be requested using the MIS website (www.mis.co.uk).
- 6) Normal office hours for Monmouthshire Building Society are Monday to Friday 9.00am to 5.00pm and Saturday 9.00am to 12 noon. Normal office hours for Monmouthshire Insurance Services are Monday to Friday 9.00am to 5.00pm.
- 7) Each applicant may make one prize draw entry with a home insurance quotation through the Society and one prize draw entry with an insurance quotation through MIS. Multiple requests for quotations will not result in multiple prize draw entries.
- 8) You must be a UK resident aged 18 years or older to participate.
- 9) All entrants to the prize draw must be able to meet the eligibility criteria for purchasing home insurance provided by our insurer, RSA, where applicable; or the relevant eligibility criteria of any insurance company with whom Monmouthshire Insurance Services provides insurance cover.
