Why do you need to complete this form?

Regulations based on the OECD Common Reporting Standard (CRS) require Financial Institutions to collect and report certain information about an account holder's tax residence. Each country/jurisdiction has its own rules for defining tax residence, and jurisdictions have provided information on how to determine if you are resident in the jurisdiction on the following website: www.oecd.org/tax/automatic-exchange/crs-implementation-and-assistance/tax-residency/. In general, you will find that tax residence is the country/jurisdiction in which you live.
